

The petitioner is requesting a new alcohol business licensing of a Class E 23 (gas station) for off premise consumption sale of malt beverages and wine sales at Ogeechee Shell located at 3618 Ogeechee Road.

The purpose of this memorandum is to submit recommendations effective 10/17/2024. The following information is being supplied on an official basis concerning a new Alcoholic Beverage License for Krunal Dhimmar.
