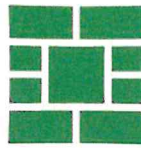

In reference to the application of **Dambar Inc. DBA The Tailgate Sports Bar & Grill / Michael Bartlett** requesting an alcoholic beverage license at **11215 Abercorn St Ste #2** (PIN 20693 03013) I have determined that the **Proposed Use, Restaurant**, within the current **B-C (Community Business)** zoning district:

I have determined that the **Proposed Use(s)**:

- Restaurant is permitted by right.**
- Is Not Permitted
- Requires a Special Use Permit from The Mayor and Aldermen
- Retail consumption dealer (on-premises consumption of alcohol) is permitted as a Limited Use with Standards. Use is limited to on-premises consumption only.**
- Is Permitted as a Non-conforming Use

Further, I have determined that **Parking** at the property:

- The parking is exempt / met (Pre-existing use).**
- The proposed use(s) are deficient in the parking standards.

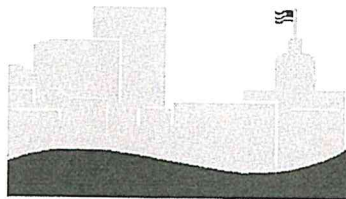
