
## AN ORDINANCE To Be Entitled

AN ORDINANCE TO AMEND THE CITY OF SAVANNAH ZONING MAP TO INCLUDE THE AFFORDABLE HOUSING OVERLAY DISTRICT (AHOD); TO REPEAL ALL OTHER ORDINANCES IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

<u>BE IT ORDAINED</u> by the Mayor and Aldermen of the City of Savannah, Georgia, in a regular meeting of Council assembled and pursuant to lawful authority thereof:

<u>SECTION 1</u>: Amend the Zoning Map to include the Affordable Housing Overlay District (AHOD) as depicted below.



SECTION 2: That the requirements of Section 3.2 of the Zoning Ordinance adopted July 18<sup>th</sup>, 2019 and the law in such cases made and provided has been satisfied. An opportunity for a public hearing was afforded anyone having an interest or property right which may have been affected by this zoning amendment, said notice being published in the Savannah Morning News, on the 9<sup>th</sup> day of April 2025, a copy of said notice being attached hereto and made a part hereof.

<u>SECTION 3:</u> All ordinances or parts of ordinances in conflict herewith are hereby repealed.
