





In reference to the application of **Mark Lehman, J.W. Marriott**, requesting an alcoholic beverage license at **300 /400 / 500 West River St** (PIN 20003 02004 / 20003 02003 / 20003 01003) (Known as Pavilion 1, Pavilion 2, & Pavilion 3), I have determined that the **Proposed Use, Restaurant with Retail consumption dealer (on-premises consumption of alcohol)** within the current D-W (Downtown Waterfront) zoning district:

Permitted by Right: *Restaurant* is permitted by right.

Is Not Permitted

Requires a Special Use Permit from The Mayor and Aldermen:

Permitted as a Limited Use with Standards: *Retail consumption dealer (on-premises consumption of alcohol)* is permitted as a Limited Use with Standards. Use is limited to on-premises consumption only. However, the property is located in the Open Container Zone and not within the Alcohol Overlay District.

Is Permitted as a Non-conforming Use

The parking is met/exempt (Pre-existing use).

The proposed use(s) are deficient in the parking standards.


