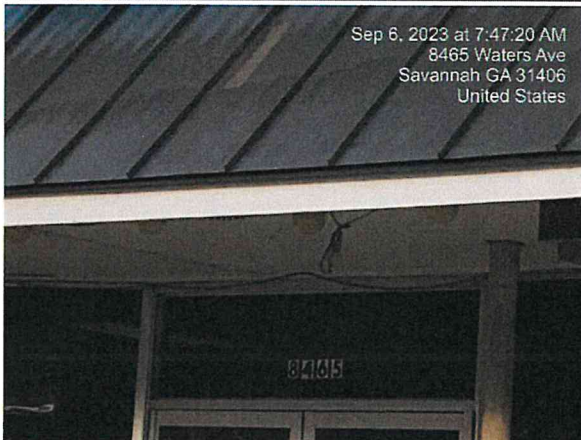
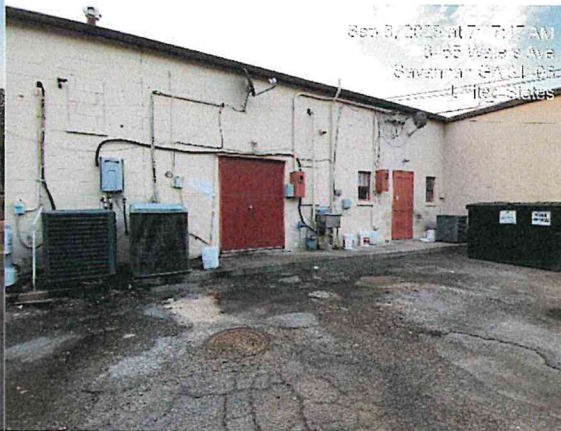


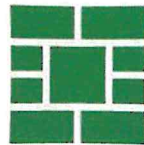

In reference to the application of **Yan Li DBA Sakura 88 Inc.** requesting an alcoholic beverage license at **8465 Waters Ave** (PIN 20494 04024), I have determined that the **Proposed Use, Restaurant with Retail consumption dealer (on premise consumption of alcohol)** within the current **B-C (Community Business) zoning district**:

I have determined that the **Proposed Use(s)**:

- Restaurant is permitted by right.**
- Is Not Permitted
- Requires a Special Use Permit from The Mayor and Aldermen
- Retail consumption dealer (on-premises consumption of alcohol) is permitted as a Limited Use with Standards. Use is limited to on-premises consumption only.**
- Is Permitted as a Non-conforming Use

Further, I have determined that **Parking** at the property:

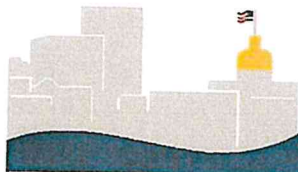
- The parking is exempt / met (Pre-existing use).**

- Obtained a new Business Location Approval for the Restaurant principal use classification on September 22, 2023, per File No 23-004944-BA.**





