

	Is Permitted by Right: The principal use classification, Restaurant, as defined in Article 13 of the zoning ordinance, is permitted by right in the said zoning district. The parcel is not within the boundaries of an Alcohol Density Overlay District.
	Is Not Permitted
	Requires a Special Use Permit from The Mayor and Aldermen
	Is Permitted as a Limited Use with Standards: The accessory use classification Retail consumption dealer (on premise consumption of alcohol) is permitted as a limited use with standards. The parcel is not within the boundaries of an Alcohol Density Overlay District. Alcohol sales are limited to on-premises consumption only.
	Is Permitted as a Non-conforming Use: Per Article 8 Sec. 8.7.24, the accessory use classification Retail consumption dealer (on premise consumption of alcohol) requires a Special Use Permit; however, the property received an alcohol license prior to the adoption of the current ordinance and is permitted as a non-conforming use.
