

Public Safety Plan

Satkaival Krupa 7 LLC DBA GX (Gas Express) Market, located at 8900 White Bluff Rd, Savannah, GA, 31406, will ensure public safety while selling alcohol products such as wine and beer from the premises.

The business hours are Monday to Sunday from 6 am to 11 pm. The business remains open seven days a week (every day).

The business and its employees ensure that their customers and purchases are checked out orderly. A proper line is formed for the checkout inside the store to maintain and order inside the store. In addition, we ensure our customers are not smoking anywhere near the gas pumps or in proximity to the building.

We have designated parking spots located at the front and on both sides of the building, which are correctly lined/marked. The parking lines allow customers to maintain order in the parking lot and safely park their cars on the premises while shopping at our establishment.

The business has proper entrance and exit roads from which customers can safely enter and exit the premises. In addition, the employees are trained and informed to keep an eye on the parking lot and to ensure only customers of the establishment are parked on the premises.

The business does not employ any security guards. Still, for security measures, the business has installed and will be installing more security cameras inside the premises and outside the building covering the parking lots.

The business and its employees will verify everyone's ID and age before selling alcohol products. Also, the business will make sure to identify underage customers and customers with fake IDs and not sell alcohol products to them. The staff/employees will be given on hands and online training to prevent serving underage customers. The POS system at the establishment has a check ID functionality that asks employees to confirm their age before serving alcoholic products.

The business will make sure that the alcohol products are not sold outside the legally allocated hours by the city of Savannah and the State of Georgia.

The business will ensure the alcohol products are outside the reach of underage customers.

The business will prevent selling alcohol products to intoxicated customers.

The business will also sell food products with alcohol products whenever possible.

The business takes proper measurements to avoid fire risks, including ensuring no light is torched inside the premises or near the alcoholic products or gas pumps. In addition, the employees are trained to respond appropriately in the event of a fire or fire risk. Fire extinguishers are available on the premises in the event of fire.

In the event of an emergency, the staff/employees are trained to ensure all the customers are evacuated from the property in an orderly and safe manner. In addition, we have security systems installed on the property to provide additional safety measures. The security system will contact the Police in the event of an emergency. But we do not solely rely on the security system; even the employees are trained/informed to contact the authority and the manager/owner in the event of an emergency and take of the situation as soon as possible, ensuring the safety of the employees and customers.
