1. *Identification of days and hours of operation.*

Monday through Thursday: 11 a.m. to 10 p.m.

Friday and Saturday: 11 a.m. to 3 a.m.

Sunday: 12 p.m. to 6:30 p.m.

Holiday hours closed Christmas thanksgiving and Easter

2. *Specific measures and procedures to address crowd management, both within and outside the premises.*

We will have dedicated lines in front of the POS system that allow customers to form a single-file line when placing orders. Outside, we will have "No Loitering" signs, and customers will need to wait outside for their orders. A designated waiting area will be provided. We are not a club or lounge, so we will never charge a cover for customers to enter. There will be a total of 8 cameras to which my general manager and I will have access. They can be monitored from a cell phone. We will allow SPD to pull footage if needed. The footage is backed up to iCloud for 30 days. The locations of the cameras will be as follows:

- One in the dining room
- One in the ordering area
- Two in the kitchen
- One to the left of the restaurant
- One to the right of the restaurant
- Two in front of the restaurant

3. *Identification of any parking areas either owned or controlled by the licensee.*

We will have 10 dedicated parking spaces for customers and an accessible area for handicapped parking, with signs to inform customers. Street parking is available on the side of the building.

4. *Means of controlling access to the premises and parking areas.*

Our parking area is for customers only; anyone who parks there without purchasing will be informed. We will have posted signs enforcing this policy. Additionally, we will have four security cameras covering the exterior of the building, including parking areas and on the interior, we have four cameras throughout the restaurant, one in the dining room area, one in the ordering area and two in the kitchen. We have three doors in the restaurant, one on the side, coming out the kitchen and two front doors

5. *Security Staffing.*

We do not hire security guards because we are a family-oriented business open to all ages. Therefore, we will not host any special events that would require security personnel.

6. *Specific measures and procedures to combat underage consumption of alcoholic beverages.*

Our staff is trained and has completed the required online tests for Savannah. They are also trained to use the birthdate calculator we have at the front to verify the age of customers presenting ID.

7. *Specific measures and procedures to combat the risk of fire.*

We will have four fire extinguishers in designated areas where staff will be trained on their locations and usage in case of an emergency. Two fire extinguishers will be located in the kitchen. The third one will be located in the dining room and the fourth one will be located in the cashier station. Staff will also be trained at closing shifts to ensure all restaurant equipment is turned off every night. The kitchen will have a 16-foot vent hood system with a fire suppression system. This equipment will be inspected by the fire department before we can pass inspection to obtain a Certificate of Occupancy (CO). All grease will be disposed of in a grease can that will be located at the back of the restaurant, where it will be picked up for recycling purposes. Also we do deep cleaning every Sunday to prevent grease buildup.

8. *Discussion of matters related to managing emergencies, including fire, evacuation tactics, assignment of specific emergency management duties to personnel, coordination with public safety officers and emergency medical matters.*

All staff will be trained on emergency management procedures, including the chain of command. They will also be trained on how to evacuate the building in case of emergencies, focusing on all three exits. Once everyone is safely evacuated, they will call 911.

9. *Where applicable, discussion of measures the licensee will undertake to visibly distinguish between patrons under and over the age of 21.*

Five Twenty Wings is a family restaurant that welcomes all ages. If anyone 21 or older wishes to order alcohol, they will be served by our professional and trained staff.
