SECURITY PLAN:

- 1) Identification of the days and hours of operation
The operating hours are Monday – Sunday 7am – 11pm.

- 2) Specific measures and procedures to address crowd management, both within and outside the premises
 - a. We have one entrance for the public. We do not allow loitering. Our staff is trained to ask anyone to leave the premises if they seem to be loitering. Our staff is trained to not provide services to customers that are not dressed appropriately. For example, customers cannot enter the store if they don't have a shirt and/or shoes. Customers have to take their hats and hoodies off upon entering the store. If customers are not willing to cooperate they will ask them to leave the premises. If they refuse we will call the SPD. We have 13 cameras total inside and outside the premises in plain view. Manager Jason Whipple (912)441-9726 has full access to the footage. We have a real time monitor behind the register for employees to view for any suspicious activity. If employees detect any suspicious activity, the suspect will be asked to leave the premises in an orderly manner or law enforcement will be called.
 - b. Our staff is trained to be aware of the audience's characteristics and know their reason for being there. We will keep our access points to a minimum. For example, the door to the counter is locked at all times and the door to the storage is locked unless employees are stocking. We will organize the staff so everyone has a clear role. The cashiers are to be behind the counter at all times. They are in-charge of checking out the customer and keeping the inventory behind the counter. The employees in-charge of stocking are stocking the floor inventory during non-busy times and monitoring the inside and outside premises during busy times. We will have a sign saying "IF You See Something Say Something" to encourage patrons to report any suspicious or life threatening activities. We will encourage employees to keep their lines orderly and fast moving, so the customers are quickly in and out the premises. During busy times of operating we will have two cashiers on duty. We will encourage customers to keep loose change at a minimum to keep lines moving fast.
 - c. We have no Loitering signs and Police enforced signs will be posted outside the premises. We will be working closely with the crime prevention officer of our area. We will sign a Citizens Agreement Act with the SPD. We will have security cameras outside the premises to view every angle. We will have bright LED lights surrounding the store area to eliminate the loitering and any illegal activity. The bright LED lights will also make the property look appealing to bring the appropriate crowd into the premises.

- 3) Identification of any parking areas either owned or controlled by the licensee
 - a. We have city parking in the front of the building.

- 4) Means of controlling access to the premises and parking areas.
 - a. No Loitering signs are posted and police enforced therefore, only customers, owners, employees and vendors are allowed in and out the establishment. We have a real time monitor for employees to suspect any suspicious persons hanging outside that may be coming into the store. The monitors will also help employees determine if persons inside the store are actually shopping or looking suspicious. For example, if a person keeps looking around and not picking up an item to buy.
 - b. Our establishment has street parking, therefore it's for public use. We are looking to cater to a neighborhood where most of our customers are foot traffic. Our target is to attract the new development of apartments that is on Montgomery Street, which is walking distance to our establishment.

- 5) Security staffing
 - a. We do not have security, but if needed we are willing to take the proper steps to get it.

- 6) Specific measures and procedures to combat underage consumption of alcoholic beverages
 - a. Customers are required to provide identification when purchasing alcohol and/or tobacco. All of our employees will take the Alcohol Certified Education Association Training and receive a Certificate upon completion. Each item that is alcohol or tobacco related in our POS system will ask for a birthdate when purchasing the item. We will have signs posted that specify identification is required for alcohol and tobacco purchases. No one under 21 is allowed inside the store.

- 7) Specific measures and procedures to combat the risk of fire
 - a. We do not allow employees or customers to smoke in the store at any time.

- 8) Discussion of matters related to managing emergencies, including fire, evacuation tactics, assignment of specific emergency management duties to personnel, coordination with public safety officers and emergency medical matters.
 - a. Employees will be trained to locate each fire extinguisher on premises, which are located behind the counters and near exits. Fire extinguishers that are on premises will be inspected annually by authorized dealers. Our location inspects daily where there are hot equipment and outlets to help prevent fire. We will check electrical equipment and remove defective equipment. We will ensure electrical cords are in good condition and replace them if necessary. We will plug appliances and lights into separate electrical outlets and avoid using extension cords. If extension cords are used, we will safely place them.
 - b. In the event of an emergency our staff is trained to evacuate the front and/or back emergency entrance and call 911 once in a safe location
 - c. Our establishment also has a panic button, which the staff is aware of

- 9) Where applicable, discussion of measures the licensee will undertake to visibly distinguish between patrons under and over the age of 21

No one under 21 is allowed in the store. Upon purchases of alcohol or tobacco our POS has an ID scan screen that requires cashiers to verify customer age before completing a transaction.
