1) Identification of the days and hours of operation

- **Hours of Operation:** The business is open from Sunday to Saturday.
- **Monday – Saturday:** 5:00 AM to 10:00 PM.
- **Sunday:** 8:00 AM to 8:00 PM.

2) Specific measures and procedures to address crowd management both inside and outside the premises

- The store layout is large; therefore, a sufficient number of employees will be on-site at all times to assist customers and ensure that indoor crowds remain orderly.
- To ensure order outside the establishment, "NO SMOKING" notices are posted on all gas pumps. Additionally, "NO LOITERING" and "NO TRESPASSING" signage is clearly displayed on the exterior of the store to prevent unauthorized gatherings.

3) Identification of any parking area owned or controlled by establishment

- **Customer Parking:** Parking spaces are clearly defined with yellow lines to ensure orderly parking for all patrons.
- **Handicap Access:** Designated handicap parking spaces are marked with official signage.
- **Safety Zones:** Parking is strictly prohibited in designated fire routes to maintain emergency access.

4) Means of controlling access to the premises and parking area

- For incoming traffic, there is a designated entry lane to the property. For outgoing traffic, a high-visibility "STOP" sign is installed to regulate movement.
- Notices are posted stating that unauthorized vehicles are subject to being towed at the owner's expense.

5) Security Staffing

- This establishment does not employ physical security guards or off-duty SCMPD officers.

- The entire premises are monitored 24/7 by a digital surveillance camera system.

6) Measures used to combat underage consumption of alcoholic beverages

- We strictly enforce a policy of asking for identification for all alcohol purchases. If a customer is under the age of 21, staff will refuse the sale of alcohol.

7) Measures used to distinguish between patrons who are over and under the age 21

- "WE ID" stickers are prominently displayed near the beer and wine sections.
- Staff are trained to verify age by checking government-issued photo identification, such as a Driver's License or Passport.

8) Measures and procedures to combat the risk of fire

- The location is equipped with fire extinguishers, a central fire alarm system, and clearly marked emergency exit signs to prevent and respond to accidental fires.

9) Emergency Management, Evacuation Tactics, and Coordination with Public Safety

- Employees are fully trained to manage emergency situations and safely evacuate patrons from the building.
- Staff members have specific roles during an emergency to ensure all areas are cleared and patrons are guided to safety.
- Employees are authorized to contact 911 (Police and EMS) immediately during an emergency and are trained to provide a clear explanation of the situation to first responders.
