1. Identification of the days and hours of operation.
 - What days of the week is your business open for?
 - Monday-Wednesday, Thursday-Saturday && Sunday Closed
 - or each day what time is your business open?
 - Monday-Wednesday 5PM to 11:45PM, Thursday-Saturday 5pm-2:45am
2. Specific measures and procedures to address crowd management, both within and outside the premises.
 - How do you make sure crowds inside your establishment remain orderly?
 - Our manager is constantly walking our floor inside and outside the bar to maintain control over intoxicated or overly aggressive guests and to prevent gatherings outside the establishment.
 - How do you ensure crowds outside (i.e. lines, smokers, etc.) your establishment remain orderly? The manager will immediately call Airport and local police if there is an incident. We work closely with Airport police to maintain a well-run and secure establishment. Cover charges will be over the weekend (Friday's and Saturday's).
 - Do you have any "No Loitering" signs? If so, how many do you have and where are they?
 - Yes, our lounge front door and main entrance is marked with signs of "NO Loitering, NO Soliciting, NO Firearms".
 - Do you have any cameras? If so, how many do you have and where are they? Who has access to the footage? What are their names and contact details?
 - Yes, there are 12 cameras located at the establishment. Locations are: two in the back outside; two on the side of the front door area; remaining eight on the inside which all managers and owners have access to the footage.  - Where do your patrons park when they're at your establishment?
 - We have parking space at the front and side of our establishment for guests and our employees park at the back of the building.
4. Means of controlling access to the premises and parking areas.
 - How does your establishment control who comes in and out of the premises?
 - ALL guests must come through front entrance and patted down by security.
 - How does your establishment control who uses the parking area?
 - Our parking areas are clearly marked for our guests. We are offset from any populated street which limits outside guests and our employees park behind our building to avoid interaction with guests.
 - Examples would be any camera, security guards, signs, gates, etc.
 - Yes, we have security guards
5. Security Staffing.
 - Do you use security guards? If so, how many? How often do you use them? Are they trained in-house or are they hired through a third-party company? Do you employ off

duty Savannah Police Department officers? If so, how many and how often? For both, list the days of the week and times they will be working.

- All nights that our lounge is open we do employ two to three unarmed military security guards. In private and unique events, the establishment manager required the owner of the event to provide with off duty police officers presence.
6. Specific measures and procedures to combat underage consumption of alcoholic beverages.
 - What does the establishment do to ensure that individuals under the age of 21 are not allowed to buy or consume alcohol? Be as specific as possible.
 - It is our policy to ID everyone. Our staff are taught to ID when trained, which is clearly in our training manual. Our employee handbook also states that we will collaborate closely with the police to prosecute any employee that serves illegally. We have ID signs throughout our establishment and in employee stations. We are also getting ID scanner machine.
 7. Where applicable, discussion of measures the licensee will undertake to visibly distinguish between patrons under and over the age of 21.
 - Does your establishment allow individuals under 21 years of age to enter? If so, how does your establishment identify and distinguish those 21 years of age and older from those 20 years of age and under? Be specific about your measures taken.
 - No, our establishment doesn't allow anyone under the age of 21. Before entering the lounge, you must present your ID at the door and every customer must be 21 years old.
 8. Specific measures and procedures to combat the risk of fire.
 - What is being done at your location to help ensure there are no accidental fires?
 - We have fire extinguishers throughout our building in case of fire. Our sprinklers system also runs throughout the building. We do not use any pyrotechnics, sparklers or anything flammable. We maintain our exit signs and emergency lights monthly.
 9. Discussion of matters related to managing emergencies, including fire, evacuation tactics, assignment of specific emergency management duties to personnel, coordination with public safety officers and emergency medical matters.
 - In the event of an emergency how is your staff trained to evacuate?
 - In case of emergency evacuation, our general manager calmly leads all back of the house employees through the back door. Our hosts and staff are trained to maintain the exit doors while our management team ensures calmly and clearly the nearest evacuation exit for guests.
 - Do certain employees have certain duties during emergencies?
 - For employees we always place them outside in case of emergency to escort the emergency response team to the emergency in an expeditious way.
 - How does your establishment contact and work with police and EMS during an emergency?
 - During an emergency remain calm and is to quickly call 911. We always work closely with police, fire and ambulance teams for any emergency.
