SECURITY PLAN

1. Hours of operation: Monday – Thursday 9:30am-9:00pm; Friday/Saturday 9:30am-9:30pm; Sunday 12:30pm-7:00pm
2. A) The front of the building has 2 “No Loitering” signs; and Visible side of building has a large “No Loitering” sign.
B) We have a total of 32 cameras; 8 outside; 24 inside.
C) Staff are trained to remove any disorderly patrons quickly and efficiently. They will contact police if they do not comply.
3. We have a large parking lot area in front of the building which is accessible by 2 driveway entrances/exits. The entire building is solely for this business.
4. The establishment is controlled by several cameras and very attentive managers who watch cameras often. Our staff is also trained to be aware of inside/outside and handling crowd management.
5. Security guards are used for holiday time frames. Mostly Thanksgiving week and Entire month of December are the busiest times of the year which we use security. Only 1-2 security guards are used at a time. Inland Security is a professionally trained security service company that we use for our needs. Most of the company staff are retired police or military. The guards are unarmed during their security work times.
6. We have several signage inside and outside the premises and our staff is all trained for selling alcohol in this store. We have signs such as: “We ID, must be 21” signs are posted on cooler doors; Live age limit sign on ceiling; Signs on the counter/register area. All registers have signage requesting customers to provide a valid ID before making purchase.
 - A) Every customer is carded unless they are clearly over 50+ years old. If there is any doubt, the customer must be carded. We have signage by the counter and on our POS display for the employees to reference current legal age limits and also signage on the ceiling with current age legal age limit.
 - B) Our POS has a option to scan IDs if necessary.
 - C) Our POS does have the ability to enter dates into it for age verification if necessary.
7. Everyone who enters the premises is carded if they appear to be below 50 years of age. Toddlers may come in with parents; However, alcohol is not served to anyone who comes in a group with underage persons. Anyone under 21 years old is not allowed to

touch any alcohol related items. We reserve the right to deny service to any customers who can not provide us a valid ID.

8. We have yearly fire inspections/reviews done and our equipment is tested/checked yearly. We have 3+ fire extinguishers located throughout the building and areas as suggested by the fire services team. We also train our employees to operate the fire extinguishers in case of any emergency.
9. In the event of an emergency, the manager on duty will oversee the evacuation of all customers/employees. There is always a manager on duty to help assist in any situation. Employees are trained to help evacuate everyone safely first, then the managers will also do a final walk through to ensure no body is left inside. There are 3 hand 911 triggers, and 2 emergency silent alarms if needed to be used in emergency. The staff is equally trained to call 911 for any emergency quickly. If there is a power outage, there are emergency lights and the staff/manager will assist in evacuating anyone inside the building outside safely. The managers have direct contacts with local police, but the staff/managers are all trained to call 911 immediately for any emergency or situation that is deemed necessary.
