- 1. Identification of days and hours of operation:** Josephs Clothiers is open Monday through Saturday 10am-6pm and Sunday 12pm-5pm
- 2. Specific measures and procedures to address crowd management both inside and outside the premise:** As a business, we have allocated sufficient resources for implementing and maintaining security measures, including training and alarm system. We will train our staff to manage crowds effectively. We will designate clear entry and exit points. If necessary we will use stanchions, barrels, or ropes to create orderly queues. We will ensure aisles and walkways remain clear to allow for easy movement and access to exits. If there are lines outside, we will use markers or barriers to create orderly queues. We will clearly communicate rules regarding behavior, noise levels, and disposal of cigarette butts or litter. We will encourage smokers or waiting customers to respect neighboring businesses and residents by maintaining order and cleanliness. We will address any concerns or issues promptly to prevent escalation. Also, we will work closely with law enforcement or local authorities to address any safety concerns or significant disruptions.
- 3. Identification of parking areas owned or controlled by establishment:** As a business located on Broughton Street we do not have parking areas owned or controlled. All parking is street and city regulated.
- 4. Means of controlling access to the premises and parking area:** We will have utilized surveillance cameras to monitor entry and exit points, as well as common areas within the establishment.
- 5. Security Staffing:** We will not be utilizing security guards or off-duty SPD officers. If in the future, we are needing security staffing then we will employ security guards.
- 6. Specific measures used to combat underage consumption of alcoholic beverages:** We will train staff on checking IDs for the correct age for alcoholic consumption. We will provide guidelines on handling different types of IDs and recognizing valid identification.

- 7. Specific measures and procedures to combat the risk of fire:** We currently have and maintain fire detection system including smoke detectors. We have extinguishers on the premises, and we will train employees on how to use the fire extinguishers. We will educate employees on recognizing potential fire hazards and reporting them promptly. We will keep storage areas orderly and clean. We will implement proper housekeeping practices to minimize fire hazards, such as regular removal of debris and trash.
- 8. Discussion of matters related to managing emergencies, including fires, evacuation tactics, assignment of specific emergency management duties to personnel, coordination with public safety officers, and emergency medical matters:** We will develop an emergency action plan (EAP) that includes procedures for evacuating employees and customers in the event of a fire. We will assign specific roles and responsibilities to employees during emergencies and conduct drills regularly to practice evacuation procedures. We have clearly marked primary and secondary evacuation routes with illuminated exit signs that are visible and unobstructed. We will adhere to local fire safety regulations, building codes, and standards applicable to our location. We will establish a relationship with local fire departments and authorities for guidance, assistance, and inspections in emergency situations. By implementing these procedures, we can effectively mitigate the risk of fire and ensure compliance with fire safety regulations.
- 9. Where applicable, discussion of measures the licensee will undertake to visibly distinguish between patrons under and over 21:** Josephs Clothiers does allow individuals under the age of 21 to enter the building, but they are not allowed to consume any alcohol.
