1. Days/Hours of Operation Sunday 12:30pm-2:30am & Monday-Saturday 11am-2:30am
2. To ensure order inside of the establishment, security will be placed throughout the lounge wearing uniforms so that they are easily identified. Security will periodically check outside and in the parking lot. SPD will be visible Friday, Saturday, and Sunday. Signs will be placed for restricted areas, smoking areas, and restrooms. Also, have emergency exit labeled in cause of emergency. There are 5 cameras in the parking lot and 8 inside the establishment.
3. No Loitering signs are placed on the front, side and back of the building.
4. There is a parking lot for customers on the front, side, and behind the building.
5. IDs will be checked before anyone is able to enter the lounge and a wristband will be placed on the wrist of anyone 21 and older. There are cameras to control the premises.
6. Security Guards will be used Sunday- Saturday there are 2 Security Guards trained in house. 1-2 Off duty SPD officers will be used Friday-Sunday
7. To control underage consumption IDs will be scanned.
8. A wristband will be placed on anyone over 21 before a drink is purchased.
9. To prevent a fire, a hood suppression system is in the kitchen, and various fire extinguishers are located throughout the building.
10. Staff will be assigned to a fire exit to direct patrons out in case of emergency and management will contact SPD or Fire Department.

## Transitional Permit (Class K)

### Security Plan Assistance Sheet

These questions were formulated to be used as an outline to aid in the creation of a suitable Security Plan when applying for the Late-Night Alcoholic Beverage License. This outline provides a general idea of the minimum concerns that should be addressed, but applicants are encouraged to provide as much detail as possible.

When reviewing the questions, the applicant should type out question being answered and use full complete sentences. **Bullet Points will not be acceptable.**

When SPD ABC Detectives review the Late-Night Security Plan, applicants may be asked to provide additional information (in the same format as the Late-Night Security Plan) before it will be approved.

Please provide your name, title, and establishment address when you submit the Plan.

1. What time will the Late-Night functions begin? **10pm**
2. What time will food service stop? **1am**
3. What is the distinction between the day and night business model? **A DJ will beginning playing on the weekends. My Goal is to hire Uniform police officers will begin there shifts on the weekend. Anyone 21 and older will receive wrist bands.**
4. Will there be live entertainment? If so, how often? **A live band will perform on Sundays only.**
5. Will employees have training in both day/nighttime functions? Describe the additional training they will receive. **Yes, employees will trained to check ID's to identify underage patrons for wrist bands. Security will be trained to assume their post positions throughout the lounge.**
6. Will the access change between day and night function? (i.e., parking, line queueing and waiting) Describe any additional access measures that will be utilized. **The access to the building will be the same. The line will not be held to attract patrons to enter. A cover charge will only be enforced on the weekend.**
7. How will age verification be confirmed? **Digital device**
8. What security will be utilized? How often? Will security be armed? **Uniform officers will be utilized on the weekends. Private security may be used during the week. I may hire a security firm.**
