

# **SLOPPEE TOPPEE SECURITY PLAN**

- 1. SLOPPEE TOPPEE OPEN 6 DAYS PER WEEK . TUESDAY –SUNDAY.**

**TUESDAY 6AM BREAKFAST LUNCH TIL 3PM CLOSE @3-5PM RESET DINNER 5PM  
CLOSE @ 9PM SAME HOURS THRU FRIDAY/SATURDAY 6AM-2AM SUNDAY  
11AM-12AM**

- 2. TO MAINTAIN CROWD CONTROL ON THE INSIDE OF THE ESTABLISHMENT WE WILL HAVE INSIDE SECURITY OUR SET UP IS COMPLETELY RESTAURANT STYLE. TO MAINTAIN CROWD CONTROL OUTSIDE IN THE EVENT THERE IS A LINE OUTSIDE WE WILL HAVE VELVET ROPES TO SECTION OFF TO KEEP PPL FROM BLOCKING THE SIDEWALKS FOR PEDESTRIANS. SMOKERS WILL HAVE A DESIGNATED AREA OUTSIDE AND OUT OF THE WAY OF PEDESTRIANS WALKING THE SIDEWALKS.**
- 3. PARKING FOR THE PATRONS ARE DIRECTLY ACROSS THE STREET 2 VACANT LOTS CURRENTLY OWNED BY THE LANDLORD. THEREFORE THERE IS PLENTY OF PARKING AND ON WEEKENDS THERE WILL BE PATROL IN THE LOTS TO KEEP PPL SAFE.**
- 4. TO CONTROL THE PARKING THERE WILL BE SECURITY TO ASSIST IN MAKING SURE THAT ONLY THE PATRONS OF THE BUSINESS WILL HAVE ACCESS TO THOSE LOTS HOWEVER DURING THE HOURS OF 10AM –5PM THE LOT IS SHARED BETWEEN THE RESTAURANT AND THE 4 EMPLOYEES OF THE LANDLORD.**
- 5. WE CURRENTLY USE IN HOUSE SECURITY WE WILL ALSO EMPLOY AN OUTSIDE SECURITY COMPANY . WE WILL ALSO MAKE CONTACT WITH MS ANGELA FRAZIER ABOUT OFF DUTY OFFICERS TO USE AS NEEDED. IN HOUSE SECURITY WILL ALWAYS BE IN THE BUILDING EVERY NITE WE ARE OPEN JUST TO KEEP CUSTOMERS AND EMPLOYEES SAFE AT CLOSING.**
- 6. TO ENSURE NO UNDERAGE DRINKING WE WILL USE ID SCANNERS TO VERIFY AGE WITH STATE ISSUED ID ONLY. ALL PATRONS DINING WITH US WILL HAVE TO SHOW ID TO ORDER A DRINK IF THERE ARE UNDERAGE PERSONS AT THE TABLE THE CUSTOMER CAN ONLY ORDER 1 DRINK AT A TIME. TO ENSURE NO DRINKS ARE BEING PASSED TO THE UNDERAGE**

**PERSON AND WE WILL ALSO USE WRIST BANDS SO THE SERVER CAN IDENTIFY WHO IS UNDERAGE AT THE TABLE.**

- 7. WE DO ALLOW UNDER 21 DUE TO WE ARE A FULL SERVICE RESTUARANT HOWEVER WE WILL IDENTIFY UNDERAGE THRU USE OF WRISTBANDS.**
- 8. OUR SERVERS AND COOKS ARE SAFE SERVE CERTIFIED AND THEY HAVE BEEN TESTED ON HOW TO PREVENT FIRE HOWEVER IN CASE OF A FIRE WE DO HAVE FIRE EXTINGUERS PLACED AROUND THE BUILDING .**
- 9. IN THE CASE OF EMERGENCY AND WE HAVE TO EVACUATE CUSTOMERS WE HAVE 3 DOORS FOR USE AND WE WILL EVACUATE ACCORDING TO WHAT SIDE OF THE BUILDING THE CUSTOMERS AND EMPLOYEES ARE ON. FOR INSTANCE IF YOUR CLOSER TO THE ENTRANCE PART OF THE BUILDING YOU WILL GO OUT THAT DOOR IF YOUR CLOSER TO THE MIDDLE OR END WE WILL DIRECT PPL TO MOVE OUT OF THE MIDDLE DOOR OR THE BACK DOOR CLOSER TO THE LANE AREA. CUSTOMERS WILL BE DIRECTED BY EMPLOYEES ALL EMPLOYEES HAVE EMERGENCY TRAINING IN OUR ESTABLISHMENT.**
