AN ORDINANCE TO AMEND THE CITY OF SAVANNAH ZONING MAP AT 11750 ABERCORN ST (PIN 20755 01002) FROM OI-E (OFFICE AND INSTITUTIONAL – EXPANDED) TO B-C (COMMUNITY – BUSINESS); TO REPEAL ALL OTHER ORDINANCES IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

Thence proceeding in a southerly direction along the approximate centerline of Mercy Boulevard for an estimated distance of 483.6 ft. to a point [X: 970525.361058 & Y: 722627.357216], said point being located along the approximate centerline of the right-of-way for Abercorn Street,

Thence proceeding in a NW direction [N 72-13-42 W] along said centerline for an estimated distance of 281.5 ft. to a point, [X: 970257.290239 & Y: 722713.279134],

Thence proceeding in a NE direction [N 19-1-2 E] along a line for an estimated distance of 227.3 ft. to a point,

Thence proceeding in a NW direction [N 12-31-59 W] along a line for an estimated distance of 265.6 ft. to a point,

Thence proceeding in a NE direction [N 77-27-58 E] along a line for an estimated distance of 283.1 ft. to a point, said point being located along the approximate centerline for Mercy Boulevard,

Thence proceeding in a southerly direction along the approximate centerline of Mercy Boulevard for an estimated distance of 155.60 ft. to a point, [X: 970583.792718 & Y: 723096.976353], said point being, THE POINT OF BEGINNING.
