- 7) counter to order beverages from where we will give wristbands / stamps to those 21 & Up.
  - Our employees will be doing mental math to determine those legally 21 and up.
- 8) Training our employees via emergency exit lights, smoke alarms, and fire extinguishers. Our space has an extremely small interior with 3 exit doors providing a swift exit. We do not have overhead suppression, this was not required by the city due to the size of our building.
- 9) In case of emergency, we will direct people in an orderly fashion off site and contact emergency personnel. The Manager on duty will have leadership in a situation such as this.
- 10) Under 21 patrons will be allowed. We will serve coffee, sodas, snacks, and various sundries for all ages to enjoy. If a customer orders an alcoholic beverage, we will inspect the ID physically as well as on our scanner. We will then provide a wristband customized to our establishment.
