- 1- What days of the week is your business open? We are open from Monday – Saturday 11a-7p
- 2- How do you make sure crowds inside your establishment remain orderly? To remain all customers in an orderly matter all employees are always paying attention to all customers and it's a very small compact area, so it's very easy to maintain a safe place to be. In case of a situation that escalates which has never happened we will have to ask the person to leave and if that doesn't work then the police will be called. The restaurant is a very small area and it is family owned therefor the environment is very friendly and we all treat our customers like family and make them feel safe and at home. How do you ensure crowds outside (lines, smokers, etc.)? your establishment remain orderly? As I stated before it's a small restaurant so not all the times we have big crowds or lines but it does happen once in a while and it goes very smooth, all customers are serviced as fast as possible and the ones that can't come inside patiently wait outside the door and for the smokers which is not seen as much, they just go outside to the sidewalk to smoke. A. Do you have loitering signs, if so how many, where? At this moment we do not have any loitering sings but we will eventually get one and it will be posted at the front entrance of the restaurant. B. Do you have cameras? If so how many? Inside/outside or both? We have a total of 4 cameras inside of the restaurant and none outside.
- 3- Where do your customers /patrons park when they're at your establishment? Our customers park at the front of the restaurant and if there is no more space they park anywhere else that there is space in the plaza.
- 4- How does your establishment control who comes in and out of your establishment? We do not have any security guards, sing or gates but we do have cameras. Everyone is welcomed unless they are loitering or disturbing our customers, which doesn't happen. How do you control who uses your parking areas? In our establishments and the ones in the whole strip on the plaza do not have designated parking spaces so really everyone parks freely anywhere there is any space for them.
- 5- Do you have security guards? No, we do not have security guards. How often do you use them? N/A Where they are trained "in house" or by a company? Doesn't apply we do not have any guards.
- 6- What do you / your employees do to ensure that individuals under that age of 21 are not allowed to buy / consume alcohol at your establishment? Each and every customer that will like to consume alcohol will be asked to provide their ID. C. Do you enter the date of birth in a point of sale and it tells the employee the age of the customer? Yes, it is entered in the POS.

This is a small establishment and as I stated before any adult that will like to purchase any beer or wine will be asked to show a form of picture ID. A.
