2. Crowd Control

2a. How do we make sure crowds inside stay orderly?

We are a small space. Most of our tables seat no more than 4, with space for a maximum of 30 people inside the building. In an instance when a customer is unorderly, we would kindly ask for them to use their inside voices and to be mindful of others around them.

2b. How do you we make sure crowds outside remain orderly?

We only offer one outside seating area that seats 2. If for some reason a crowd gathers, we will ask them to disperse. In the rare case of a safety concern, we would call the non-emergency police line or 911 if needed.

2c. Do we have no loitering signs?

2d. Do we have any cameras?

We have a total of 5 cameras. 4 outside, 1 inside. (With plans to add additional indoor cameras.) Only the owner has access. (Andria Canella, (912) 509-7996)

3. Identification of parking areas

3a. Where do your patrons park when they are at your establishment?
Street parking only.

4. Means of controlling access to the premises and parking areas

4a. We use signs and employees to control the flow of the restaurant.
4b. We do not control any of the public parking spaces our customers use.

5. Do we have security guards or security staffing?

5a. No. Our establishment is small and holds no more than 30 people.

6. Specific measures and procedures to combat underage consumption of alcoholic beverages.

6a. What does the establishment do to ensure individuals under the age of 21 are allowed to buy or consume alcohol?
We train all of our servers and management to card anyone who looks under the age of 40. We require valid ID checks. We also require all servers and management to hold STP cards.

7. Specific measures and procedures to combat risk of fire.

7a. We keep all fire extinguishers maintained and inspected and regularly train our team to be aware of potential hazards and immediately correct them or notify management.

8. Managing Emergencies

8a. In the event of an emergency, how is your staff trained to evacuate?
In the event of an emergency guests are directed to the nearest and safest emergency exit.

8b. Do certain employees have certain duties during emergencies?
Management will make sure all kitchen staff are evacuated, restrooms are cleared and that the building is empty.

8c. How does your establishment contact and work with police and EMS during an emergency?

We will use the first available phone to contact emergency police and fire agencies and will follow their recommendations.

9. Where applicable, discussion of measures the licensee will undertake to visibly distinguish between patrons under and over the age of 21.

9a. Individuals under 21 are allowed inside our establishment. Patrons wishing to consume alcohol must present a valid ID, which will be checked by an employee who has their STP card.
