He knew how to get things done. If you needed help with home repairs, he was around to lend a helping hand. If you needed a new heating and cooling system, roof, plumbing, he knew who to call. When our neighborhood pool needed new lighting, Bobby spent his afternoons rewiring and adding new fixtures. Everyone has at least one "Mr. Bobby" story.

Bobby and his family also owned the historic Holland House Restaurant. For over 18 years, Holland House served breakfast and lunch to the residents of Savannah. You never knew who you would see at the Holland House. Hospital staff, politicians, first responders and everyday Savannahians stopped by to enjoy some of the best soul food in the south.

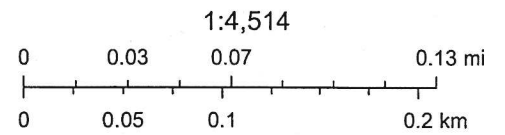


# SAGIS Map Viewer

 Property Boundaries (Parcels)

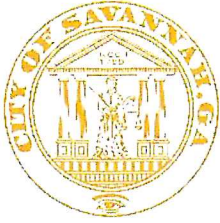
