

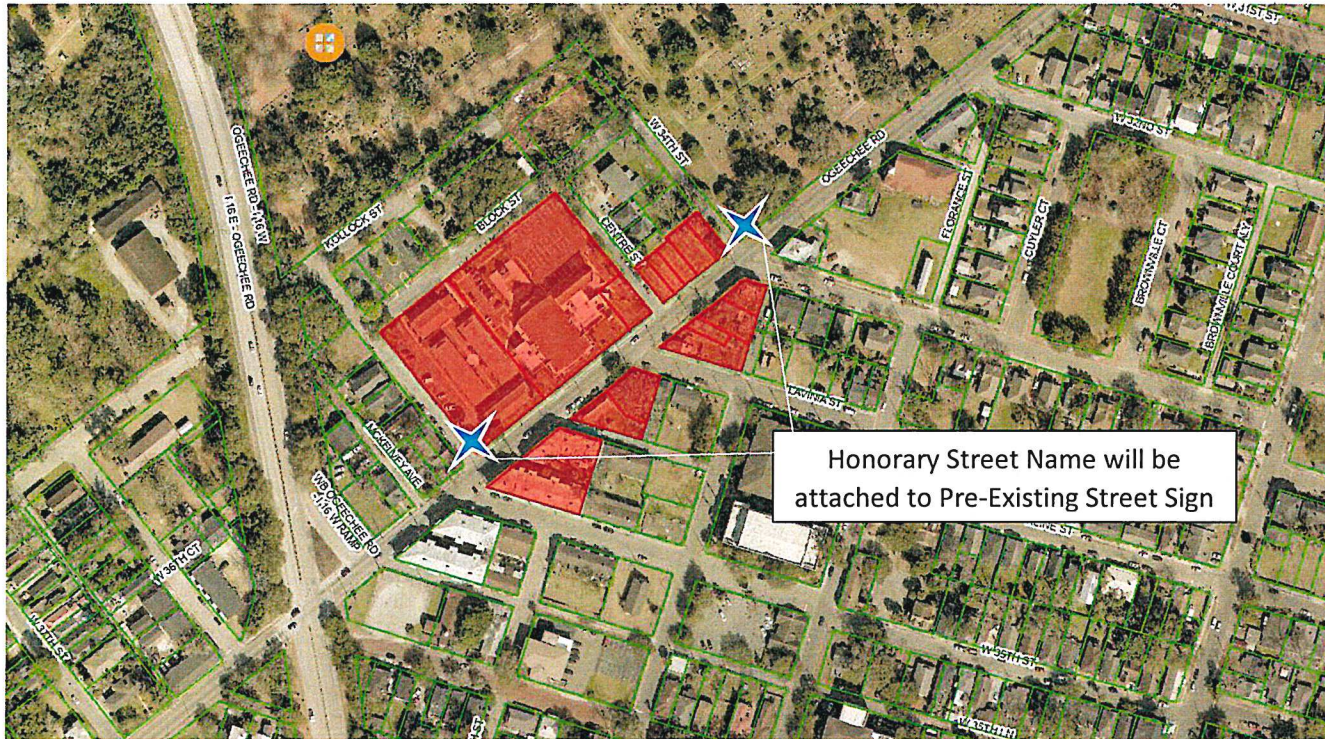
Honorary Street Designation Request- “Bishop C.M. Bailey Way”

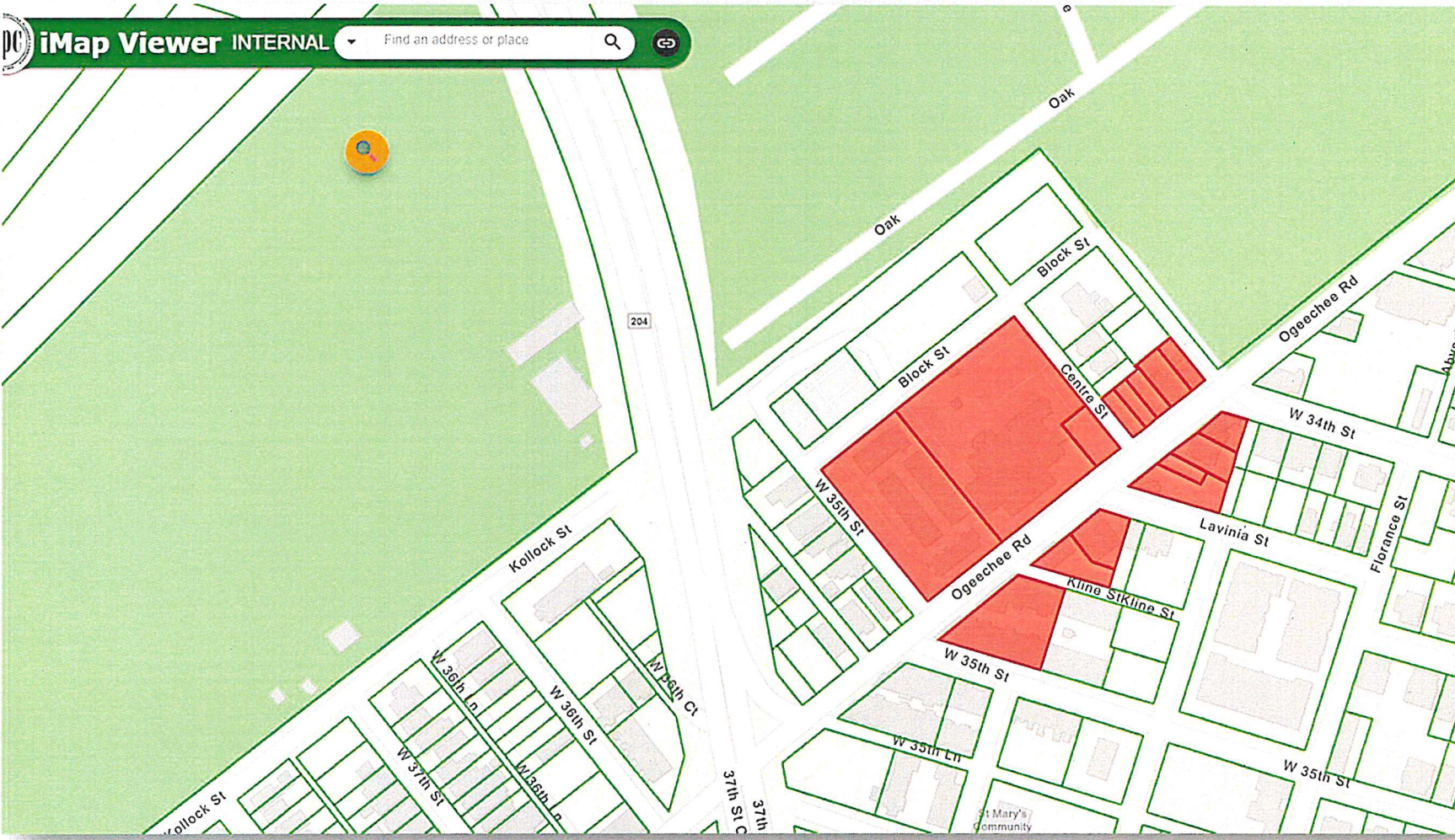

Statement of Reason- Community Contribution submitted by Petitioner

A Brief History of the Late Bishop C.M. Bailey,

This year, the United House of Prayer for All People would have been celebrating the 15th Bishopric Anniversary of our former bishop, the honorable C.M. Bailey, who passed on August 11th, during our 97th Annual Holy Convocation, in Savannah, during the week of September 18th through 24th, 2023. The United House of Prayer was established in West Wareham, MA in 1919 by the late Bishop C.M. Grace. Bishop Grace was succeeded by the late Bishop W. McCollough, who was succeeded by the late Bishop S.C. Madison, who was succeeded by Bishop Bailey.

From that little building in West Wareham, the Lord has blessed the United House of Prayer to grow to include 136 congregations in 27 States and the District of Columbia. There are 17 congregations in Georgia. Our presence in Savannah includes 1805 Ogeechee Rd., 4107 Sixth St., 5009 Montgomery St., 1209 W. Victory Dr., and 2301 Bay St.

The United House of Prayer has established affordable housing in various communities around the nation, including Savannah, scholarship opportunities for our youth, extracurricular activities to include inter-congregational sports teams, musical bands, and choirs.

Bishop Bailey inspired a dynamic spiritual renewal within the United House of Prayer. He tirelessly traveled throughout the nation teaching and preaching the word of God, encouraging young and adults to rededicate their lives to Christ.

Bishop Bailey had also continued the building programs begun by his predecessors. He had overseen the building of new housing complexes and House of Prayer edifices. He updated the luxury buses to provide our membership with more modern modes of transportation.

As a special tribute to Bishop Bailey, we are seeking to rename a portion of Ogeechee Rd., between 34th and 35th St., as Bishop C.M. Bailey Avenue, Boulevard, Drive, Road, Street, or Way. This renaming has been endorsed by the honorable Mayor of Savannah, Van R. Johnson.

I previously provided Mayor Johnson with a United House of Prayer publication, the “2023 Truth and Facts of the United House of Prayer For All People” which gives a more in depth history of Bishop Bailey’s 15 year bishopric. I would be glad to provide it to you as well.

Requirements for Honorary Street Naming Designations. (Sec.4-1104)

Purpose

- ✓ Honorary street name designations are intended to recognize individuals who have made significant contributions to the City. The designation will be a temporary assignment of the honorarium and shall not interfere with the official name of the street.

Restrictions

- ✓ Roadways under the control of the Federal Highway Administration, Georgia Department of Transportation or Chatham County are not subject to honorary naming.
- ✓ Honorary designations shall be limited to one approved designation per City Council member per calendar year.
- ✓ Individual family tributes, commercially concerned and corporate-related recognitions shall not be eligible for honorary designation.

Requirements

- ✓ The proposed namesake made a sustained contribution over an appreciable time period, exerted efforts of benefit or significance to local, state or national affairs and/or demonstrated leadership in governmental, cultural or historical affairs, humanitarian efforts, or community development;
- ✓ The proposed namesake made contributions that beneficially changed the nature and characteristics of the community;
- ✓ The proposed namesake resided in the City for at least 5 years.
- ✓ A statement of reasons supporting the honorary naming request, including a discussion of the historical significance, contributions, heroic service or personal sacrifice by the honoree to the City, state or nation;
- ✓ Identification of the particular section or block of an existing City street for which the honorary designation is sought.
- ✓ A supporting petition signed by not less than 51 percent of all property owners abutting the subject right-of-way
- ✓ An endorsement by the current Mayor, an at-large alderman or the alderman representing the district in which the property is located.
- ✓ A check for \$150 made to the City of Savannah


