Subject: Revenue Ordinance Modification

The purpose of this memo is to summarize the requested change to the 2025 Revenue Ordinance specifically relating to the Tap in Fee for the Southwest (SW) Quad Service Area.

Existing Conditions:

Currently, water resources charges tap in fees shown in **Exhibit A** for the SW Quad Service Area

Those fees were based on recovering capital improvement cost to handle the expected demand in the SW Quad. They were calculated off of old estimates. Now that we have began to undergo these improvements and have more clarity on the development in the service area, there have been some cost updates that we need to account for in order to adequately recover City investment in the service area.

Exhibit B Shows those costs and how they will need to be recovered on a per ERU basis.

The service area is based on the capacity gained with the improvements that are completed or underway.

Recommendation:

Given the following information, it is recommended that the City modify Article U Section 5 of the revenue ordinance per the markups shown in **Exhibit C.**
