Mayor Johnson opened the hearing.

Alderwoman Miller Blakely asked for Item #15 to be pulled from the Agenda, Mayor Johnson indicated Item #15 was for hearing purposes and would proceed with the hearing.

Alderwoman Miller Blakely asked Mayor Johnson to recuse himself from discussion and voting on Item #15 due to campaign contributions from Jerry and Jack Wardlow. Mayor Johnson declined.

PRESENTED by Bridget Lidy, Director of Urban Planning and Design.

Speakers:

- Ms. Ardis Wood - (joined meeting later) she is concerned with having more trees along the Parkways and asked for the definition of a Parkway (is it an ingress & egress?).
- Mr. Chat Howard - His property backs up to Rockingham Farms (343 Burkhalter Road). He is concerned with receiving tax notices when the project is completed and he is concerned about whether this is the correct zoning for the property. He requested Council to delay a vote on the property until the property address is corrected.
- City Manager Monahan stated they could delete the reference to the property address.
- Mayor Johnson recommended postponing this item until the property address is investigated and corrected. He asked Mr. Bell to look at the situation during the meeting and get back to Council with a resolution to the problem before the meeting has ended.
- City Manager Monahan confirmed that Mr. Howard's address as 343-A Burkhalter Road, while the property in question for Rockingham Farms is 343 Burkhalter Road. He also noted that the description for the property is 1,036.69 acres and would not be confused with Mr. Howard's property. Mr. Monahan informed Mr. Howard that the county zoning is not changing.
- Alderman Palumbo spoke on behalf of Ms. Wood. He asked Ms. Lidy if there would be any signage erected along Veterans Parkway and Truman Parkway with trees being lost. Ms. Wood also requested the definition of a Parkway.
- City Manager Monahan commented that there will be no billboards along Veterans and Truman Parkway and to his knowledge, there is no definition of a Parkway.
- Alderwoman Miller Blakely asked Mr. Howard if any staff has contacted him in referenced to the project. Mr. Howard answered, no.

- Mayor Johnson expressed concern that no staff member contacted Mr. Howard. He asked the City Manager to postpone this item until all concerned property owners are contacted.
- City Manager Monahan and Mayor Pro-Tem Dr. Shabazz reported that the property is in the unincorporated area of Chatham County.
- Mr. Monahan recommended that Item #15 be a First Reading only, and city staff will contact concerned property owners before the second reading.

Mayor Pro-Tem Dr. Shabazz moved to close the hearing for Item #15, Alderwoman Lanier seconded. The motion passed unanimously. City Manager Monahan announced that twenty letters were sent to residents in the surrounding Rockingham Farms area, with six letters going to residents on Burkhalter Road. When letters are sent, they are only sent to those residents within three hundred feet of the project. The City Manager will instruct staff to send notification letters to all residents along Burkhalter Road, prior to the second reading of the Ordinance.

Public Speaker:

Matthew Emmer - opposed. He is concerned with added heavy truck traffic on this interchange.

Alderwoman Lanier asked Mr. Lotson what is the closest residential area to the property, and if there were any plans for future growth in the area. Alderwoman Lanier moved to close the hearing for Item #17, Alderwoman Miller Blakely seconded. The motion passed unanimously.

Mayor Johnson opened the hearing.

PRESENTED by Bridget Lidy, Director of Planning and Urban Design.

Public Speaker:

-Gary Wiggin (Petitioner) - supports. He described the property and the reason for the zoning change. He advised Council that when the land swap was finalized with the City of Savannah, his understanding was the zoning would be heavy industrial.

Alderwoman Lanier asked if there was a potential project in place that would warrant heavy industrial use.

Alderwoman Wilder-Bryan requested a map of the area before voting.

Ms. Lidy shared the map via screen shot and described the streets involved.

Alderwoman Gibson-Carter asked if Mr. Wiggins would answer the Alderwoman's question, if there is a potential project in place that would warrant heavy industrial use. Mr. Wiggins answered, there are a couple potential projects after the zoning is approved.

Alderwoman Wilder-Bryan questioned if MPC reviewed this particular land swap and did they give approval.

Mayor Johnson and City Manager Monahan explained that Georgia Law does not require MPC to be involved in a land swap if there are no zoning change.

Ms. Lidy informed Council that the zoning of light industrial was a staff error.

Alderwoman Lanier moved to close the hearing for Item #18, Alderwoman Gibson-Carter seconded. The motion passed unanimously.

Mayor Johnson opened the hearing.
PRESENTED by Marcus Lotson, MPC.

Public Speakers:

-Attorney Harold Yellin & Patrick Malloy - described the stacked units are opening from a hallway rather than an outside entry. They further explained the project beginning in 2017 and the various adjustments and amendments that came before Council. All buildings surrounding this area are a part of the planned unit development (PUD) according to height.

Alderwoman Gibson-Carter asked if any of the units will be affordable (lower income) housing. Mr. Yellin described the units as single family, market rate.

Alderman Palumbo asked for the definition of stacked townhouses and where the parking will be assigned. He asked for the necessity of going from a sixty foot to eighty foot building. Mr. Lotson described each unit as one floor with underground parking. Attorney Yellin described the heights as varying from one building to the next for skyline preservation. Alderman Leggett asked about the height requirements. With the existing height, the character of the Savannah skyline will be effected negatively. Alderwoman Miller Blakely asked if any of this area is considered an 'Opportunity Zone', and should it include some type of affordable housing. Alderwoman Lanier recommended incentives in the project.

Mayor Johnson recommended giving the owners an opportunity to give a presentation to the Council.

Alderwoman Wilder-Bryan asked for more affordable housing. This project needs to be revisited by this Council with a presentation before moving forward.

Alderwoman Gibson-Carter asked the City Manager if any bonds were issued for this project and if any community benefits were attached to the project. She asked if the City currently has projects being developed and receiving subsidies through the Opportunity Zone. Going forward, she requested the City Manager to evaluate how many projects are being developed and how many companies/developers are receiving Federal Tax Credits within the parameters of the Opportunity Zones.

Mayor Pro-Tem Dr. Shabazz spoke on the previous adjustments/amendments to the Eastern Wharf Project and her dissatisfaction with the project, including a thirty-three million dollar bond issue for the parking garage under the Council's goal of economic development and poverty.

Mayor Johnson suggested closing the hearing and moving this project to the first item on Council's next work session to view the complete

presentation and drawings for the project.

Aldерwoman Lanier moved to close the hearing for Item #19, Mayor Pro-Tem Dr. Shabazz seconded. The motion passed unanimously.

Clerk of Council Mark Massey received one comment from the public for Item #27, which he provided to the Mayor, Aldermen, and staff. After the first reading was considered the second and a request that an ordinance be placed and passed upon its adoption, Mayor Pro-Tem Dr. Shabazz moved to approve Item #27, Alderman Purtee seconded. The motion passed unanimously.

RESOLUTIONS

[28. Adoption of a Resolution Approving the Expansion of the 90-day Pilot Open Container Zone in a Specific Area of the Victorian Neighborhood District](#)

Clerk of Council Mark Massey received several comments from the public for Item #28, which he provided to the Mayor, Aldermen, and staff. Alderman Leggett suggested holding Item #28 due to misinformation. Alderwoman Miller Blakely asked what is the specific area of the Victorian Neighborhood District and does it extend all the way down to Victory Drive. Mayor Johnson identified the specific area for Alderwoman Miller Blakely.

Alderwoman Gibson-Carter recommended additional research of the area, due to the college student presence in that area.

Mayor Johnson discussed a bar card program with a bystander program and identification that was repealed by the previous Council. He agrees with Alderwoman Gibson-Carter to establish a similar program.

City Manager Monahan agreed to move forward with Alderwoman Gibson-Carter's recommendation in establishing a bar card program and the training that goes along with that program.

Item #28, HELD/CONTINUED as announced by Mayor Johnson.

[29. Approval of a Resolution Requesting the Georgia General Assembly Adopt Local Legislation to Adopt the Hotel/Motel Excise Tax Under O.C.G.A. 48-13-51\(b\)](#)

Mayor Johnson gave a brief outline of local legislation to adopt the hotel/motel excise tax, the City Council's recent discussions pertaining to the legislation, and the Council's responsibility going forward to present the local legislation to the General Assembly.

Alderwoman Miller Blakely asked if adopted, will it include the Water Works Building.

Mayor Johnson recommended the legislation specify the projects. Mr. Bell was asked if the Water Works Building could be included as a specific project.

City Manager Monahan will prepare a Resolution that will reflect the specific projects (including the Water Works Building) and a quarter page legal advertisement will be published identifying the specific projects included in the legislation.

Mayor Johnson indicated, this is only an estimate. All designations of funds will depend on the final cost of the Tide-To-Town and the Water Works Building.

Alderwoman Gibson-Carter recommended that Council approve the Resolution as written and adjust the numbers after approval.

Mayor Pro-Tem Dr. Shabazz stated that Council should not have to ask Visit Savannah permission to receive any hotel/motel tax monies for projects, or for other 501(c)(6) organizations to be involved.

Alderwoman Lanier wanted to clarify with the City Manager, that the 14.7% will not be earmarked/allocated to separate projects at today's meeting.

Alderman Palumbo asked that the City Manager read into the record the percentages.

City Manager Monahan identified the following percentages for the Resolution: 37.5% to the City of Savannah's unrestricted General Fund; 33.8% for destination marketing organization; 14% for the Savannah Convention Center; and 14.7% for tourism product development.

a. Alderman Palumbo moved to approve Item #29, Alderwoman Wilder-Bryan seconded. The motion was not voted on.

b. A substitute motion was made by Alderwoman Gibson-Carter to approve Item #29 as written, without specific project percentages, Mayor Pro-Tem Dr. Shabazz seconded. The motion was not voted on.

City Manager Monahan reported that the percentages as read or readjusted by Council is required by law and will need to be identified in the Resolution, but not the individual designations.

Alderwoman Gibson-Carter rejected the project list percentages, stating the percentages as presented by Mr. Bell added the tourism product development that was created by the City's administration. That item was not originally part of the legislation. She asked if there were parameters

within the 14.7% for the African American Chamber, the Hispanic Chamber, DBE's and women/minority owned businesses. Mayor Johnson and City Manager Monahan answered no, their percentages will be taken from the 33.8% for destination marketing organization, provided they are a 501(c)6 organization.

It was explained that the 14.7% goes to the City of Savannah for Council to decide the distribution to any 501(c)(6) organizations.

Alderman Miller Blakely asked if the Savannah Chamber or Visit Savannah will receive any of the hotel/motel tax money. Mayor Johnson and the City Manager explained the Chamber is not a 501(c)6 and therefore would not receive any of the money but Visit Savannah would. She wants to make sure other organizations will be able to receive some of the allocation of funds.

Mayor Johnson read the motion: approval of a Resolution requesting the Georgia General Assembly adopt Local Legislation to adopt the Hotel/Motel Excise Tax Under O.C.G.A. 48-13-51(b) with distributions as follows; for the City of Savannah General Fund , for destination marketing organizations; for the Savannah Convention Center; and for tourism product development.

c. Alderman Palumbo moved to approve Item #29 as amended, under O.C.G.A. 48-13-51(b), Alderman Wilder-Bryan and Alderman Leggett seconded. The motion passed, 8-1-0. Alderman Gibson-Carter voted no.

[30. Approval of a Resolution Confirming the Mayor's May 31, 2020 Declaration of Local Emergency](#)

Mayor Pro-Tem Dr. Shabazz moved to approve Item #30, Alderman Lanier seconded. The motion passed unanimously.

Alderman Wilder-Bryan moved to approve Item #31, Alderman Purtee seconded. The motion passed unanimously.

Alderwoman Wilder-Bryan thanked the City Manager and staff for the completed financial audit report.

Mayor Pro-Tem Dr. Shabazz shared that she communicated with Senator Lester Jackson and received a letter from Georgia Public Service Commissioner Jason Shaw on the extension to July 15th on disconnections which she read in part, in the record.

Alderwoman Miller Blakely reported that individuals between the ages of 16-24 can apply for employment with Dr. Zenobia Williams, (912) 644-0476. She congratulated all the elected officials that won on Tuesday, June 9th. Woodhouse Apartments is in need of household items, any donations will be picked up, if you send the address to the City Manager.

Alderwoman Gibson-Carter responded to dozens of email messages in relations to allocation of City funds and she wants to develop a resolution in that regard.

Alderwoman Wilder-Bryan and State Representative Carl Gilliard will feed the hungry at the PARC on June 20th from 12:00 noon until all the food is gone.
